President's Report

QUGS carries on for another year and continues to grow, with the sixth consecutive year of increasing membership, with little sign of slowing down.

Furthermore, this year, QUGS has gained two additional partners, *The Magic Vault* and *Vault Games*, and has retained partnership with *Ace Comics, Mind Games, Netherworld*, and *Presents of Mind*. We hope you all have found use for these discounts that can be found on our membership cards. We're hoping to increase the range of discounts for next year. We hope QUGS acquires further partners in 2020.

The QUGS collection has also slightly enlarged this year with the addition of *Kingdom*ino and Smash Up, both kindly donated by the UQ Computing Society, along with Dune. QUGS also acquired the remaining Terraforming Mars expansions, Venus Next, Prelude and Colonies, as well as backing the Turmoil Kickstarter.

However, there have been two barriers to further increasing the QUGS collection; financial and storage. With the increasing membership, pizza expenses have become somewhat of a burden on the society's funds. The collection has also nearly outgrown the suitcase, and so the society has purchased a second "coffin", which should allow a few more years of games purchasing.

The QUGS *Magic: The Gathering* Thursday night events has also experienced growth consistent with the Monday night events. The society has funded prize boosters awarded to the winners of the weekly tournaments, which has been a welcome addition.

An initiative I started this year was to extend the Monday games sessions to eight hours on one public holiday each semester. This has been modestly successful, and have established a nascent tradition of a semi-annual *Twilight Imperium* game.


Finally, I would like to thank all the members of QUGS who attended our events and made them what they were. I hope for QUGS to continue to be bigger and better in 2020 with your help.

Hello everyone

The treasurer's report will be brief, there are only three things that I want to cover.

Firstly, income for QUGS in the 2019 financial year totalled \$1'543.00, while expenditure totalled \$2'096.80, for a net loss of \$553.80. Additionally, the UQ Union provided a \$630.00 grant. Below is a small table of total income and expenditure by category.

On a related note, QUGS has passed audit for 2019, which means we get to exist for another year. The audit itself was standard. Most of our income was from memberships. The only thing worth note is the fact that the majority of our spending for this year was related to purchasing pizza for events. This leads me into my second point.

In terms of raw numbers, we spent \$1'186.58 (including \$315 from UQ Union grant) on pizza for events like the first games night we host each semester. We will cover this later when we do general business inside the AGM, but in brief, we will need to try to spend less money on pizza.

Otherwise, QUGS survives for one more year. I look forward to enjoying more games nights with all future members.
